Berkeley County Florence Update #13

Opens additional shelter, announces shelter transportation and sandbag distribution to end at end of day

MONCKS CORNER, S.C.- (Thursday, September 13)- Berkeley County will open a shelter at Westview Middle School today at 2 p.m. in preparation for Hurricane Florence.

The following Berkeley County shelters are open, in addition to Westview Middle School.

- Macedonia Middle School
- Cross High School
- Berkeley Middle School
- Cane Bay High School- This a pet-friendly location. Citizens must stay with their pets during their time at the shelter. Pet owners are NOT allowed to drop-off their pets at the shelters.
- Goose Creek High School- Berkeley County citizens are welcome at this shelter. This is the primary location for Charleston residents.
- St. Stephen Elementary
- **Special needs shelter: If you require a special needs shelter, please call DHEC at 1-800-578-2031.**

Berkeley County school district has provided transportation from Cainhoy Elementary to Macedonia Middle School. That will stop at 6 p.m. Thursday, September 13.

PLEASE NOTE: Those who stay in shelters are responsible for their bedding, food, water, and any other necessities they may have.

SANDBAGS: Berkeley County will stop sandbag distribution at the end of the day Thursday, September 13. Since Monday, Berkeley County has distributed more than 133,000 sandbags and 2,900 tons of sand to 27 locations (listed at the bottom).

Berkeley County emergency operations moved to 24 hours at 8 a.m. Thursday, September 13 in preparation for Hurricane Florence. It will remain in 24-hour operations through the duration of the storm.

Additionally, Berkeley County Government created a Hurricane Florence Damage Assessment Facebook. Residents are encouraged to “LIKE” this page and utilize it as a tool to capture pictures and notes from the storm. OPERATIONS: Berkeley County emergency operations is at OPCON 1. OPCON 1 means a disaster or emergency situation is in effect, full-fledged emergency response operations are on-going. Berkeley County is in the highest state of emergency operations.

BERKELEY COUNTY AIRPORT: The Berkeley County airport will close at 6 p.m. Thursday, September 13 and will remain closed until further notice.

Berkeley County Council issued a State of Emergency declaration at the County council meeting Monday evening.

Berkeley County Government offices are closed until further notice.

LANDFILL AND CONVENIENCE CENTERS: The Berkeley County landfill and convenience center will be closed until further notice.

COURTHOUSE AND COURT CASES: Berkeley County Courthouse is closed until further notice. All court cases will be rescheduled. Summary Court cases for this week are canceled. All parties will receive new court information by mail.
