**ORDINANCE NO. 23-09-66**

**AN ORDINANCE TO AMEND ORDINANCE 92-11-24 TO PROHIBIT THROUGH TRUCK TRAFFIC ON ADDITIONAL ROADS AND HIGHWAYS IN BERKELEY COUNTY, SOUTH CAROLINA AND TO AMEND THE PENALTIES ASSOCIATED THEREWITH**

**WHEREAS**, South Carolina Code 56-5-4210 allows restrictions on loads and weights and speed limits for certain roads and highways under the jurisdiction of local authorities when necessary to provide for the public safety and convenience on certain roads and highways; and

**WHEREAS**, Berkeley County Council desires to provide and promote for the public safety and convenient travel along such roadways; and

**WHEREAS**, Berkeley County Council has determined that a prohibition on through truck traffic on certain roads and highways in Berkeley County is necessary at this time.

**NOW, THEREFORE, BE IT ORDAINED** by Berkeley County Council, in a meeting duly assembled, that:

(A) All through truck traffic is prohibited on the following roads in Berkeley County:


- (1) Throughout the entirety of the Sangaree residential area
- (2) Thurgood Road, Goose Creek
- (3) Reflectance Drive, Charleston
- (4) Turtle Pond Road, Summerville

(B) For the purpose of this section, the following definitions shall apply:

- (1) *Truck* means every motor vehicle having three or more axles.
- (2) *Through truck traffic* mean truck traffic moving from the beginning point of the road to the ending point of the road without stopping.

**BE IT FURTHER ORDAINED** that such notice shall be prominently displayed on or around adjacent roadways in a format similar to that which is used by South Carolina Department of Highways and Public Transportation indicating “THRU TRUCKS PROHIBITED”; and

**BE IT FURTHER ORDAINED** that the violation of any provision of this ordinance shall subject the violator to a fine not to exceed Five Hundred (\$500) Dollars or a term of imprisonment not to exceed Thirty (30) days.


