INSTRUCTIONS FOR COMPLETING THE LICENSE AND CERTIFICATE OF MARRIAGE

Please read these instructions CAREFULLY before completing and returning the License and Certificate of Marriage.

There are three (3) original copies of the License and Certificate of Marriage. Each copy is labeled on the bottom of the license as: BRIDE/GROOM, PROBATE JUDGE, and PROBATE JUDGE/DHEC COPY. The BRIDE/GROOM copy should be kept by the couple. The other two copies **MUST BE RETURNED TO BERKELEY COUNTY PROBATE COURT WITHIN FIFTEEN (15) DAYS OF THE DATE OF MARRIAGE.**

*****ALL LICENSES MUST BE COMPLETED IN BLACK OR BLUE INK ONLY*****

BOX (20) <u>SIGNATURE OF PARTY A:</u>	Please have PARTY A SIGN, in ink, his/her name as it is printed on the license in box A (1). Please make sure to sign <u>IN</u> (not above) the box.
BOX (21) <u>SIGNATURE OF PARTY B:</u>	Please have PARTY B SIGN, in ink, his/her name as it is printed on the license in box B (1). Please make sure to sign <u>IN</u> (not above) the box.
BOX (22) <u>DATE OF MARRIAGE:</u>	Please PRINT or TYPE in full, the MONTH, DAY, and YEAR the marriage was performed. <i>Example: January 1, 2018.</i>
BOX (23) <u>PLACE OF MARRIAGE:</u>	Please PRINT or TYPE in BOTH the CITY and COUNTY in which the marriage was performed. <i>Example: Moncks Corner, Berkeley.</i>
BOX (24a) <u>OFFICIANT-SIGNATURE:</u>	Please sign your full name here in INK only. <u>PLEASE DO NOT PRINT or TYPE on this line.</u>
BOX (24b) <u>OFFICIANT-PRINT NAME:</u>	Please PRINT or TYPE your full name in this box.
BOX (24c) <u>OFFICIANT-TITLE:</u>	Please PRINT or TYPE your full title in this box. <i>*If you are a South Carolina Notary Public, please make sure to include your notary expiration date in this box.*</i>
BOX (24d) <u>OFFICIANT-MAILING ADDRESS:</u>	Please PRINT or TYPE your full mailing address in this box.
